I. EXECUTIVE SUMMARY

he women's movement across Europe is currently experiencing an ever-intensifying backlash against women's rights, resulting in increasing discrimination and oppression of women and the shrinking of public space for women's civil society. Furthermore, increasingly gender-neutral policy making is leading to a gradual negation of violence against women as 'gendered', no longer recognising the term as the disproportionate impact of male violence against women. This is currently leading

to a reversing of many gains the women's movement has made over decades, in particular to fundamental rights and protections of women. Against this background, WAVE remains resolute in our commitment to protect and advance women's human rights to live a life free from violence. In the face of adversity, our network stands united and advocates with clarity for the key role of women's specialist services in preventing and addressing violence against women and girls. 2023 was a pivotal year in our advocacy efforts, as we focused our energies on strengthening key legal instruments such as the draft EU Directive on Combating Violence Against Women and Domestic Violence, the revision of the Victims' Rights Directive, and the EU accession to the Istanbul Convention. WAVE actively contributed to numerous international and European advocacy meetings, building new alliances as well as fostering collaboration with political decision makers and CSO partners, whilst

demonstrating resilience in the face of a challenging political climate. Furthermore, WAVE strengthened its collaboration with international political stakeholders such as EU parliamentarians, as well as Council of Europe and United Nations representatives, and feminist civil society partners such as The Advocates for Human Rights and the EL*C (Euro-Centralasian Lesbian Community), and allies such as PICUM, IPPF, ILGA Europe, End FGM, LaStrada International, Amnesty International and Human Rights Watch.

An instrumental development this year was the growth of the WAVE regranting programme which now encompasses two different funding schemes for members. This capacity building initiative is dedicated towards strengthening women's specialist services that are particularly underfunded, as they are heavily impacted by the current backlash against women's rights and/or other crisis related challenges. Additionally, WAVE distributed 20 microgrants for national advocacy and campaigning efforts, underscoring our commitment to sustaining feminist civil society engagement also on national level. Furthermore, the WAVE Youth Ambassadors initiative continued to play a crucial role in engaging young people in advocacy and awareness-raising activities, and empowering youth to contribute to the prevention of violence against women and girls, particularly in the digital sphere.

This year brought several key changes, from the introduction of the WAVE Regional Meetings to the composition of a newly elected WAVE Board. We extend sincere appreciation to outgoing Board members welcoming the new Board. As the network grows, so "As WAVE members continue to work in solidarity with women survivors of violence, it is imperative to reaffirm the indispensability of women's specialist services in effectively preventing and tackling violence against women. WAVE's commitment to advocating for the preservation and elevation of women's specialist services remains unwavering." does the WAVE office, and we were delighted to welcome two new office staff-members in 2023, including Event Coordinator Amina Reiss and Accounting Assistant Rüya Langenberger. We are particularly grateful to our now 174 members, without whom the network would be incomplete.

In 2023, WAVE continued to advance European data collection and research on violence against women, creating significant publications emphasising women's and children's rights in child custody proceedings through the WAVE toolkit for victim-friendly judicial practice in child custody, contact and visitation matters, strengthening women's specialist services impacted by conflict and war, and the importance of primary prevention. The WAVE Country Report 2023 was published, highlighting the status and value of women's specialist services and countries' national fulfilment of Istanbul Convention standards. Furthermore, the publicly accessible

WAVE database of women's specialist services, a cornerstone for supporting women survivors of gender-based violence, represents an additional aspect of our ongoing commitment to providing vital resources. All of WAVE's dissemination and communication efforts contributed to increasing knowledge, fostering awareness, and offering support to CSO practitioners, key decision-makers and women and girls experiencing GBV.

These accomplishments reflect our personal and collective dedication to advancing gender equality, preventing and addressing violence against women and girls, and strengthening the capacities of our network and members. As we look ahead, WAVE is eager to continue these efforts in the pursuit of a world where women and girls, in all their diversity, can enjoy their human rights.

II. WAVE MILESTONES IN 2023

JANUARY

As we enter the new year, we commence with our **WAVE office planning meeting** dedicated to outlining our strategic priorities and determining the most effective ways to seamlessly integrate them into our annual activities. The **first advocacy meetings** of the year are taking place in Brussels, paving the way for this year's advocacy efforts rooted in strengthening collaboration to showcase the effectiveness of feminist civil society organisations and women's specialist services.

FEBRUARY

The online **training sessions** organised by medica mondiale together with Medica Zenica and Medica Gjakova on the topic of **"Feminist solidarity in practice – How to strengthen ourselves to support others in challenging times"** start in February and are running until May. The first two sessions are conducted on 2 February and 2 March within the frame of the **Multidisciplinary Training 2023** and focus on "Feminist self- and collective care and context analysis". We also hold our first **WAVE Solidarity Meeting** of the year, open to all members who are directly or indirectly impacted by conflict and crisis situations.

MARCH

The WAVE Youth Ambassadors develop their Europe-wide **"I Am a Woman/Girl in Cyberspace" campaign** aimed at preventing and addressing cyber violence and advocating for the importance of women's and girls' digital rights and their protection in the digital sphere. Our **International Women's Day** initiatives focus on advocating for robust feminist legislation within the EU, particularly emphasising the draft EU Directive on Combating Violence Against Women and Domestic Violence. At the end of the month, our annual **Discussion Forum** takes place facilitating exchange between members and encouraging open and informal discussions on country developments and burning issues.

APRil

Our inaugural online pilot meeting of the **WAVE Regional Meetings** is organised with the aim of strengthening WAVE's regional cooperation and consolidating advocacy efforts. The activities of the EU-funded **WAVE Regranting** initiative begin of which seven proposals from Belgium, Bulgaria, Croatia, Cyprus, Hungary, Malta and Spain have been selected.

MAY

The **Spring Advisory Board meeting** welcomes 40 WAVE members representing 32 countries. The meeting focuses on network development activities at WAVE, capacity building efforts across the network, advocacy updates in line with WAVE's strategic priorities, and the upcoming WAVE Country Report 2023. Our **training sessions** conducted by medica mondiale, Medica Zenica and Medica Gjakova conclude, and we are exploring additional collaboration options for the new year. Meanwhile, a **charity event** is organised within the WAVE Youth Ambassadors initiative in Vienna, Austria, focusing on young people's involvement in preventing sexual harassment in public spaces and nightclub settings.

JUNE

We host a **webinar** on "Violence against women and children in custody cases and visitation rights" within the WAVE project "Safeguarding and empowering children" welcoming 77 participants from WAVE member organisations to discuss cooperation among different stakeholders and mechanisms on women's and children's rights in custody proceedings. Within the WAVE Youth Ambassadors initiative, the first ever **WAVE Rave** is hosted in Vienna, Austria, with more than 300 attendants aimed at tackling period inequality. We also partner with the **2 A Billion campaign** by Bon Iver, which aims to raise support, awareness, and person-to-person connections in an effort to end gender inequality, domestic violence, and sexual abuse.



JULY

Under the topic "resisting against antifeminism", the annual **WAVE Youth Ambassadors Conference** takes place in Vienna, Austria, offering our young feminist activists specific skills and knowledge on how to react in antifeminist situations, and providing them with effective communication tools. In Tirana, Albania, the first WAVE Youth Ambassadors **intergenerational talk** is held aimed at promoting safety and protection in digital spaces. Our partners of the WAVE/OSCE project **"Preventing and responding to gender-based violence during the war and in post-war settings"** also join us in Vienna to discuss the continuation of the project and the upcoming training manuals on the implementation of the toolkit's strategies.

AUGUST

This month is dedicated to preparing for the approaching conference and capacity building events. We intensify advocacy efforts ahead of the upcoming negotiations to agree on a common text for the proposed EU Directive on Combating Violence Against Women and Domestic Violence, emphasising the demands of women's specialist services. Additionally, we conduct a **social media campaign** on the revised Victim's Rights Directive to ensure that the voices of women and their children, and those of women's specialist services continue to be adequately represented in the text of the directive.

SEPTEMBER

15 participants are trained in our annual **WAVE Training Institute**, this year focusing on effectively monitoring the implementation of the Istanbul Convention. Furthermore, the training centred around the key role of feminist civil society organisations and women's specialist services in the monitoring process and how to best channel their efforts. On the **International Safe Abortion Day**, we emphasise the urgent need to strengthen global efforts to ensure universal access to high-quality healthcare services, including safe, affordable, and legal abortion.

OCTOBER

Our **25th annual WAVE Conference** on "Institutional violence and its impact on women's human rights across Europe" is held in Madrid, Spain, organised in collaboration with our Spanish member Aspacia. The conference encompasses eight in-person workshops. The **Fall Advisory Board meeting** brings together 37 WAVE members to discuss network representation and development. Our new Board members, which were elected during the **WAVE General Assembly** happening at the start of the month, are officially introduced to the network during the Advisory Board Meeting.

NOVEMBER

The 2023 **Fempower Magazine** dedicated to the importance of preventing and tackling institutional violence on women and girls is officially published. Through webinars, podcasts, articles, videos, and in-person as well as online workshops we showcase together with WAVE members, WAVE Youth Ambassadors and dedicated partners within the feminist movement the myriad ways activism can advance women's human rights and foster gender equality through legislative change, powerful advocacy, responsible media reporting, access to vital information, and realm of artivism in the scope of the **16 Days of Activism Against Gender-Based Violence**.

DECEMBER

As we wrap up the year, WAVE proudly presents two significant outputs from ongoing projects and working groups. One addresses the critical issues surrounding women's and children's rights in custody proceedings in the form of a toolkit, while the other emphasises the importance of primary prevention exclusively addressing WAVE members. Additionally, the much-anticipated **WAVE Country Report 2023**, shedding light on the status and value of women's specialist services in preventing and addressing gender-based violence against women in Europe, is finally published.

III. OUR WORK

1. Advocacy and campaigning

- ✓ Actively engaged in over 90 consultations and events with relevant stakeholders from national governments and permanent representations, EU institutions, the Council of Europe, and civil society organisations to discuss and promote the recognition and support of women's specialist services.
- Played a pivotal role in the legislative process by proposing comprehensive amendments to the draft EU Directive on Combating Violence Against Women and Domestic Violence, and the revision of the Victims' Rights Directive, emphasising the need for primary prevention measures, women's specialised victim support, and the integration of intersectionality.
- Forged alliances to advocate for robust Directives, engaging in collaborative forums and joint online campaigns, particularly emphasising the EU's accession to the Istanbul Convention amid a prevailing backlash against women's rights.
 - Distributed 20 microgrants during the 16 Days of Activism to support national advocacy and campaigning initiatives, fostering diverse activism and unique partnerships.

The main aim of WAVE's Advocacy & Campaigning (A&C) area is to drive systemic change that empowers women and girls to live free from violence while promoting the vital role of women's specialist services in preventing and addressing violence against women and girls. By strategically advocating for the recognition and support of women's specialist services, we aim to influence political decision-makers to prioritise and implement strong legislation aimed at preventing and addressing VAWG across Europe. Building upon the groundwork established between 2021-2022, 2023 has played a vital role in nurturing and refining the strategies within the A&C pillar of work. During this period, we focused on reinforcing the established foundation, fostering deeper

connections with our partners, and promoting stronger engagement among our members. These efforts have been pivotal in increasing the visibility of WAVE amongst policymakers across Europe, as well as an increased awareness of the key role served by women's specialist services in preventing and holistically addressing gender-based violence against women and girls.



In 2023, WAVE actively engaged in consultations with civil society organisations and stakeholders, did advocacy visits to Brussels, Strasbourg, France, New York, and other locations, and had influential discussions with diverse decision-makers, emphasising the vital contributions of women's specialist services, thus elevating our collective influence by adopting a proactive approach.

We engaged with key stakeholders at the European Commission, Permanent Representations of EU Member States, Members of the European Parliament, and feminist civil society organisations.

In terms of advancing feminist legislation, advocating for the inclusion of women's specialist services in EU Directives was a cornerstone of our efforts this year. As such, we actively discussed and proposed comprehensive amendments to the draft EU Directive on Combating Violence Against Women and Domestic Violence, the revision of the Victims' Rights Directive, the Recommendation on Harmful Practices, and campaigned for the ratification of the Istanbul Convention. Likewise. WAVE contributed to drafting the Council of Europe's Gender Equality Strategy 2024-2029 and participated in its formal presentation in Strasbourg. We advocated for a balanced approach of acknowledging the disproportionate impact women face concerning equality issues, particularly gender-based violence and the significance of involving men and boys in fostering healthy masculinities. These initiatives aimed at strengthening legislative frameworks to protect women's rights across Europe, and our role was to underscore the necessity of prioritising specialist support for women survivors and allocating resources proportionate to the significant impact borne by women. Simultaneously, WAVE played an active role in the EU Gender Equality Week, emphasising the indispensable role of women's specialist services and highlighting the potential repercussions of gender-neutral policies and programs on the advancement of feminist policies and women's rights. The advocacy efforts concerning the draft EU Directive on Combating Violence Against Women and Domestic Violence and the revision of the Victims' Rights Directive also included the submission of detailed

amendments to members of the European Parliament across various sections of both Directives. WAVE's primary advocacy points on the EU **Directive on Combating Violence** Against Women and Domestic Violence emphasised the need for active inclusion of primary prevention measures, enhancement of women's specialised victim support, protection of children affected by intimate partner violence, integration of intersectionality in all proposed chapters with a focus on migrant women, and promotion of the involvement of feminist civil society organisations as implementation partners. WAVE submitted a total of nine comprehensive position papers containing detailed amendments, recommendations, and evidence related to the raised points.

In conjunction with our ongoing efforts, our advocacy efforts for the Victims' Rights Directive concentrated on two key areas. Firstly, we aimed to clarify and promote stakeholders' understanding of the critical role played by women's specialist services. These services address the unique needs for protection and support required by victims of GBV against women. Secondly, we emphasised the importance of complementary protection levels outlined in EU legislation. This recognition underscores the necessity for specialised support in addition to general support services, emphasising that the latter cannot replace the former.

2023 also marked a year of actively forging alliances to bolster its advocacy efforts. We participated in a coalition of civil society organisations dedicated to advocating for robust Directives, engaging in a collaborative forum that fostered ongoing dialogue and mutual support throughout the legislative process. Concurrently, we collaborated in joint online campaigns and initiatives with our partners. By cooperating closely with other feminist networks, we expanded our outreach and amplified our collective voice in championing women's rights, notably in advocating for the EU's accession to the Istanbul Convention. In this area, despite facing a prevailing backlash against women's rights, WAVE remained steadfast in its commitment to advancing the effective implementation of the Istanbul Convention across member countries and advocating for the EU's accession to it. Our advocacy efforts extended across various platforms, including social media campaigns and public statements to raise awareness about its critical importance.

Continuing with strategic campaigning, WAVE solidified its narrative and visual identity for its flagship campaigns, International Women's Day and the 16 Days of Activism. The International Women's Day initiatives concentrated on advocating for robust feminist legislation within the EU. To commemorate the 16 Days of Activism we curated a calendar of events under the theme "The Power of Diverse Feminist Activism: Shaping Equality and Women's Human Rights". This campaign celebrated the diverse spectrum of feminist activism, recognising that these distinct perspectives are not mutually exclusive but rather mutually enriching. Embracing this diversity empowers our members to leverage the full potential of activism to drive societal change, foster a more equitable world, and ensure every voice is heard. Alongside a selected number of in-person and online events, we also produced two video series, one highlighting the voices of young activists, and the other one emphasising the role of collaboration among networks.

Equally vital is the capacity-building aspect of the A&C pillar, particularly the initiatives developed with WAVE members. During the 16 Days of Activism, aligning with national

contexts. WAVE distributed 20 microgrants to support national advocacy and campaigning initiatives. These microgrants aligned with the overarching theme of the 16 Days, showcasing diverse activism. Among our members, unique partnerships emerged, such as collaboration with a male football team in Georgia, highlighting inclusivity. In Armenia, an impactful art exhibition coupled with a roundtable discussion addressed gaps in the domestic violence response system. Furthermore, one Austrian member crafted a pocket-sized online leaflet titled "What to do in case of domestic violence? Detecting violence and taking action". This user-friendly resource, resembling a map, offers clear guidance for recognising signs of domestic violence and is designed for easy distribution by counselling services assisting women and girls. These activities represent the breadth of initiatives undertaken by our members as part of this crucial campaign, highlighting the significance of microgrants as a form of capacity building and support.

In summary, 2023 was a landmark year for WAVE's Advocacy & Campaigning initiatives, characterised by strategic engagements, active legislative participation, and steadfast advocacy for the visibility of women's specialist services. Through consultations, advocacy visits, and influential discussions with decision-makers, we elevated our collective influence by adopting a proactive approach, emphasising the indispensable contributions of women's specialist services across diverse platforms and locations, and remaining at the forefront of European policy dialogue. Moreover, our capacity-building initiatives with WAVE members underscored our commitment to empowering advocates and empowering women, thus exemplifying WAVE's dedication to driving systemic change.



YOUTH

WAVE sees the inclusion and engagement of youth as a crucial pillar of strengthening feminist movements across Europe. Since October 2018. the WAVE Youth Ambassadors initiative aims to provide a platform for youth activists in order to facilitate youth participation, youth campaigning and youth inclusion within the context of preventing and eliminating violence and discrimination against women and girls. At the end of 2022, the third generation of WAVE Youth Ambassadors started its two-year term towards raising and amplifying youth voices across Europe:

At the beginning of the year, WAVE Youth Ambassadors Lena Östlund, Raphaëlle Jouannic and Ilvana Dedja developed the European "I Am a Woman/Girl in Cyber**space**" campaign, which is set to run until the end of their mandate. The goal is to raise awareness of the importance of women and girls' digital rights and advocate for their protection in cyberspace through policy development, community education, women's involvement in cybersecurity, changing mindsets as well as multi-stakeholder cooperation with young people in Europe. The campaign started on International Women's Day, by releasing video "A woman in Cyberspace: Building a Better Digital Future for Women and Girls", created by WAVE Youth Ambassadors, Lena Östlund and Ilvana Dedja, who met with Lella Violet Halloum, Digital Changemarker and Power of Youth Champion, to discuss the challenges of digital safety for women and girls. In line with this, the two ambassadors created one podcast episode for the WAVE podcast "No More Violence Against Women" in March, highlighting the need to end cyberviolence. In the episode, they discuss cyberviolence against women and girls as a deepening challenge to gender equality and democracy with Dr. Eleonora Esposito, a Seconded National Expert at the European Institute for Gender Equality (EIGE), and look into the lack of data and clear definitions; various forms of online violence such as harassment, stalking & doxing, intersectionality, as well as policies and recommendations. The second podcast episode, published in July and produced within the youth initiative, was by WAVE Youth Ambassador Ines Consonni who talked to Farah Abou Harb, a Political Science graduate working as a women, peace and security program analyst in the field of peace process support, about the state of women's rights, gender (in)equality and violence against women and girls in the MENA region, particularly in Lebanon.

On 19 May, the Austrian association About Later organised a charity event in the frame of a club party to collect donations for WAVE. The event was opened with a panel discussion where WAVE Project & Youth Ambassador Coordinator Branislava Aradjan and WAVE Youth Ambassador Aliz Bineth presented the work and efforts of WAVE including the successful WAVE Youth Ambassadors initiative. This led to a fruitful exchange on youth's and young people's involvement in preventing violence against women and girls around sexual harassment in public spaces and nightclub settings and additionally gave room to exploring new ways of collaboration.

On 11 June, WAVE Youth Ambassador Aliz Bineth organised the WAVE Rave in Vienna, Austria, made possible through the civic engagement project funding from the Open Society University Network she received as a Central European University student. The open-air event welcomed more than 300 people and was aimed at tackling period inequality and lifting the taboo about menstruation through feminist DJ performances, period workshops and quizzes, as well as discussions with experts and activists. Aliz Bineth also started a petition for menstrual products to be made available free of charge at all educational institutions managed by the City of Vienna, which received 216 signatures during the event.

As part of the "I Am a Woman/Girl in Cyberspace" campaign, the WAVE Youth Ambassadors also aim to conduct a series of intergenerational talks in selected European countries to raise awareness and advocate for better protection of girls' and women's rights in the digital sphere. These intergenerational talks centre around creating a hub for girls and women, experts and policymakers to share their experiences and insights on how to effectively promote safe digital spaces. Furthermore, girls and women are enabled to enhance empowering skills to navigate online interactions more safely. The intergenerational talks introduce innovative perspectives on the importance of safeguarding the rights of women and girls in the digital realm. The first talk was initiated by ambassador Ilvana Dedja and hosted in Tirana, Albania on 6 July in collaboration with the Young Professional Network, a cooperation platform composed of young professionals and youth organisations. The talk included a

panel comprised of Megi Llubani, Research Analyst at MDRC Nadia Guni, Human Rights Lawyer at the Center for Civic Legal Initiatives and Arjola Hoxha, Cybersecurity Expert at BKT. The next intergenerational talk is set for February 2024.

From 8-9 July, the current generation of WAVE Youth Ambassadors gathered in Vienna, Austria, to attend the annual WAVE Youth Ambassadors Conference. This year's conference highlighted the importance of "resisting against antifeminism". Our group of young feminist activists from across Europe had the opportunity to gain specific skills and knowledge on how to react in antifeminist situations, were provided with effective communication tools, and delved into critical conversations on the crucial role of self-care for activists. The conference was facilitated and led by Irene Zeilinger of the WAVE member organisation Garance ASBL, based on the organisation's brochure "Let's shut down antifeminism! - The verbal self-defence quide for feminists".

The next opportunity for ambassadors to meet in-person presented itself in October. Three WAVE Youth Ambassadors had the opportunity to attend the 25th WAVE Conference on "Institutional violence and its impact on women's human rights across Europe" in Madrid, Spain from 16-17 October 2023. By attending the conference, the ambassadors had the opportunity to engage in fruitful discussions and exchange with WAVE members on the need to advocate for issues affecting young people in the context of preventing and addressing violence against women and girls. Additionally, we produced video content with the ambassadors on the importance of youth inclusion in feminist activism, which was later shared during the 16 Days of Activism Against Gender-Based Violence 2023 in our Activist Spotlight Series social media campaign.

Effectively, the WAVE Youth Ambassadors participated in WAVE's 16 Days of Activism campaign under the theme "The Power of **Diverse Feminist Activism:** Shaping Equality and Women's Human Rights". Together with WAVE, WAVE Youth Ambassador Aliz Bineth supported two in-person events: On the International Day for the Elimination of Violence Against Women, a dynamic fundraising art exhibition curated by Rifka Fehr, a student at the Central European University, in collaboration the university took place in Vienna, Austria, donating 80% of the proceeds from the event to WAVE. On 30 November, the "Empowering Civil Courage Workshop: Responding to Gender-Based Violence within the Framework of Austrian Laws and Women Specialist Services" was organised in collaboration with the Central European University and Austrian WAVE member AÖF - Association of Autonomous Austrian Women's Shelters with the aim to equip students with knowledge and skills to respond effectively when someone is experiencing gender-based violence, and to offer insights into how to react in accordance with Austrian laws and the available women's specialist services.

This year, the WAVE Youth Ambassadors initiative did not only grow on the digital sphere through their independent "WAVE Network Youth" social media accounts (Facebook and Instagram), but effectively surpassed digital boundaries, extending its impact through proactive outreach and engaging interactions with youth across Europe. Our ambassadors played a pivotal role in mobilising youth, fostering intergenerational connections, and reaching diverse audiences to enable meaningful discussions and create sustainable positive change.

CAPACITY BUILDING

WAVE strengthens the capacity of its members to carry out and continue their invaluable work through trainings, knowledge exchange, partner projects, conferences, and webinars. These activities include two key trainings per year, namely the Multidisciplinary Training and the WAVE Training Institute. Additionally, WAVE hosts several webinars throughout the year and facilitates capacity building during the annual WAVE Conference as well as the Youth Ambassadors Conference.

WAVE REGRANT-ING INITIATIVES

Through the WAVE Regranting Initiative 2023, WAVE was able to strengthen the capacity of members through financial support, distributing seven grants in total amounting to 50,000 € to members in Belgium, Bulgaria, Croatia, Cyprus, Hungary,

Malta, and Spain. The aim of the regranting scheme was to support WAVE members to develop local, context-specific actions to prevent and combat all forms of violence against women and girls, thus contributing to the promotion and implementation of international standards at EU level and advance EU values within the framework of the EU Gender Equality Strategy 2020-2025. The projects supported in 2023 ranged from a cooking and selfcare project where mental health assistance was provided to asylum seeking women who were exposed to sexual and gender-based violence, to national advocacy projects for the protection of women from violence, awareness raising projects to counter the violation of women's rights in the context of sexual and digital violence and prevention projects targeting girls and young women.

WAVE also secured another 3-year core-grant from a philanthropic foundation which enabled us to enhance our regranting programme and reach members outside the EU, namely in Albania, Bulgaria, Croatia, Czech Republic, Hungary, Moldova, Poland, Romania, Slovakia, and Slovenia. In addition, we included two more countries specifically affected by the ongoing backlash against women's rights and democracy, which are Armenia and Serbia, based on a members' assessment.

In total, WAVE disbursed 105,000 € to 12 members in 11 countries with 57,5% of WAVE members being eligible to at least one regranting scheme.

WEBINARS

On 19 June, we held the webinar **"Violence against women and children in custody cases and visitation rights"** within the WAVE project "Safeguarding and empowering children" for WAVE members. The goal of the webinar was to bring together experts on women's and children's rights in custody proceedings, to give an overview of burning issues in child custody proceedings, but also to discuss strengthening cooperation among different stakeholders and mechanisms on women's and children's rights in custody proceedings, and among WAVE members. Furthermore, the webinar addressed the main findings from GREVIO reports around children's rights in custody proceedings, relevant policies across Europe, promising practices to combat the concept of "parental alienation" and related or similar harmful practices, and different contexts and opportunities for cooperation among WAVE members on the topic. 77 participants followed the webinar in which Dr. Marceline Naudi, individual WAVE member, Senior Lecturer Gender Studies (University of Malta), and Andrea Czak, FEM.A – Association of Feminist Single Mothers (WAVE member organisation, Austria) presented.

On 10 October, the WAVE webinar on "The Istanbul Convention: the effects of the European Union's accession for EU and non-EU countries" led by Sara de Vido, Associate Professor of International and EU Law (Ca'Foscari University of Venice, Italy), invited WAVE members to delve into the EU accession to the Istanbul Convention including its implications to EU and non-EU members, advocacy for the implementation of the Istanbul Convention, and the role of the Commission as the coordinating body which will ensure the Convention's implementation. Additionally, the webinar addressed how the Istanbul Convention can inspire new legislation at the domestic and/or regional level, even broadening its scope to include information and communications technology (ICT) facilitated violence. The discussion also included the ongoing process for the proposed EU Directive on **Combating Violence Against Women** and Domestic Violence. 35 participants attended this webinar.

During the 16 Days of Activism Against Gender-Based Violence, we hosted three webinars. The first was held on 28 November and was open to the public. The webinar focused on "Responsible **Reporting on VAWG and Fem**icide – A Media and Activist Perspective" as a follow-up to last year's 16 Days webinar on challenging the media towards ethical reporting of violence against women. The webinar brought together journalists, media professionals, and activists to explore the critical role of the media and responsible, ethical, and feminist-oriented reporting in addressing femicide and advancing gender equality. The aim was to highlight principles that should guide responsible reporting, emphasising respect for victims, their consent, and the avoidance of victim-blaming. Additionally, the importance of steering clear of sensationalism in media coverage, ensuring that reporting remains focused on the issues at hand, was at the forefront. A key aspect was to hold perpetrators and authorities accountable for femicide, underscoring the media's responsibility in uncovering systemic failures and advocating for change through investigative journalism. The presenters during the webinar were Teresa Parker, Head of Media, Brand & Relationships, from WAVE member organisation Women's Aid Federation of England (UK), Philine Dressler, Campaigns Director, and Flora Bachmann, Campaigner of the civil society campaign organisation #aufstehn (Austria), and Hristina Cvetinčanin Knežević, member of the group "Journalist against violence against women" and co-author of "Guidelines for Media Reporting on Violence against Women" (Serbia). The webinar welcomed 13 participants.

The second webinar, held on 4 December, was entitled **"Empowering Equality: Navigating the EU VAW and DV Directive**"

enabled the public to dive deep into the draft EU Directive on Combating Violence Against Women (VAW) and Domestic Violence (DV) to explore the nuances of this directive and the importance of partnership-building for joint advocacy among feminist organisations. The webinar emphasised the power of language and the significant impact of including women in legal texts, exploring why it constitutes a pivotal step towards achieving true gender equality. Additionally, the webinar shed light on the challenges faced in advocating for the criminalisation of rape within EU member states, addressing the reasons behind hesitations and reluctance in embracing this legislation. The webinar was hosted by WAVE Senior Advocacy Advisor Eliana Jimeno, Ilaria Todde, Advocacy Director at EuroCentralAsian Lesbian* Community, and Katharina Choe, Communication and Media Relations, unsichtbar - an intermedia, interdisciplinary initiative against sexualised violence. 14 participants attended this webinar.

The third webinar during the 16 Days and the last webinar of 2023 was held on 7 December dedicated to "Feminist approaches to counter gender-based violence during and after conflict". Based on the toolkit "Responding and preventing gender-based violence during the war and in post-war setting" (WAVE in partnership with the OSCE Gender Issues Programme/WIN Project), the webinar explained how certain strategies could be used in conflict settings to prevent and respond to gender-based violence. Furthermore, the webinar highlighted, based on the experiences of feminist organisations from Georgia, Armenia, Bosnia and Herzegovina and Ukraine, the different approaches to fight gender-based violence during and after conflict which are implemented in their respective countries. The speakers during the webinar were

Inessa Adilkhanyan, Sexual Assault Crisis Center (Armenia), Ekaterine Gamakharia, Women Fund Sukhumi (Georgia) and Gorica Ivić, Foundation "United Women" Banja Luka (Bosnia and Herzegovina). The webinar welcomed 25 participants.

KEY TRAININGS

In 2023, four online training sessions were organised by medica mondiale together with Medica Zenica and Medica Gjakova from February to May 2023 on the topic of "Feminist solidarity in practice – How to strengthen ourselves to support others in challenging times". The first two sessions were held on 2 February and 2 March within the frame of the Multidisciplinary Training 2023 and focused on "Feminist self- and collective care and context analysis". The aim was to support WAVE members in practicing feminist self-care at an individual as well as organisational level. Participants were enabled to effectively care for themselves under the challenging circumstances of conflict, and increase their understanding of the



effects of conflict dynamics on oneself, on teams and/or organisations with regard to feminist perspectives and to wellbeing, among other. The training sessions were attended by 20 participants from 13 countries, mainly Eastern European countries and those directly and indirectly impacted by the war in Ukraine. Pia Frohwein, sociologist, certified trauma counsellor, peacebuilder and feminist (medica mondiale), Dr Sabiha Husić, psychotherapist, interreligious peacebuilder, and the director of the NGO Medica Zenica in Bosnia and Herzegovina, Leonita Gojani, human rights activist and psychosocial counsellor at Medica Gjakova, and Shpresa Frrokaj, clinical psychologist and certified trauma counsellor, provided their expertise and knowledge as trainers during the Multidisciplinary Training.

The WAVE Training Institute 2023 was held in-person from 21-22 September in Vienna, Austria, entitled "Monitoring the Implementation of the Istanbul **Convention: Empowering Fem**inist Civil Society for Effective Contribution". This training aimed to equip WAVE members with the requisite skills to monitor the Istanbul Convention's implementation in ratified countries. With 15 active participants, the training provided a comprehensive understanding of the monitoring phases, enhancing members' advocacy capacity for women's specialist services and the implementation of the Istanbul Convention. Biljana Brankovic, independent researcher - consultant, member of GREVIO, Council of Europe (2015–2023), and Marcella Pirrone, independent lawyer-consultant, WAVE president and co-founder of DiRe facilitated the two-day event. The training drew keen interest from the WAVE membership and sparked ideas for future interventions and projects on this topic.

25TH ANNUAL WAVE CONFER-ENCE

The WAVE Conference is an important forum for building and strengthening relationships within the membership as well as relevant stakeholders, and for raising awareness on the issue of violence against women and girls. In 2023, the central theme of the conference was **"Institutional violence** and its impact on women's human rights across Europe", focusing on the pervasive impact of institutional violence on women and girls, the different forms in which it manifests, and the key role women's specialist services have in denouncing and undoing this type of violence. By looking at violence against women and girls through a multidisciplinary lens, the conference centered around the link between institutional violence and state accountability.

The conference was held in Madrid, Spain, from 16-17 October, in collaboration with our Spanish member Fundacion para la Convivencia Aspacia. The first day of the conference was open to the general public and WAVE members, while the second one was only open to WAVE members. Participants were offered a platform to share knowledge, experiences, and promising practice examples. The conference encouraged discussion on progress and challenges from a feminist perspective to address institutional violence, and its impact on diverse groups of women and their children, exploring institutional violence from the political context, the institutional practice and the personal sphere. The public day of the WAVE Conference welcomed 186 participants in Madrid, Spain.

WORKSHOPS

During the annual WAVE Conference 2023 "Institutional violence and its impact on women's human rights across Europe", eight in-person workshops were held on the second day of the conference. Topics covered included feminist strategies against the perpetuation of institutional violence, institutional violence in the context of migration, child custody proceedings and violence against older women, and institutional violence in the absence of rule of law, among other. The workshops were designed to be interactive and encourage discussion, foster networking among participants as well as expand their knowledge of effective approaches to preventing and addressing institutional violence. In total, 131 professionals attended these workshops.

NETWORK DEVELOPMENT

Network development activities are a crucial part of WAVE's internal capacity building. Their aim is to increase the institutional capacity of the network and to strengthen partnerships and relationships between members and the governing bodies of WAVE for sustainable growth. These activities include giving space to members for networking and discussions during Advisory Board Meetings, our General Assembly, and other forums and meetings. Strengthening the overall network capacity also entails continuous work of the WAVE team in managing the membership, corresponding with members and ensuring effective communication and information-sharing, monitoring and evaluation, fundraising, as well as strategic planning.

ADVISORY BOARD MEET-INGS AND GEN-ERAL ASSEMBLY

The WAVE Advisory Board supports the WAVE Board in intensifying the coordination and planning for the WAVE Network, and to ensure

representation from all regions. It consists of one Delegate and one Co-delegate (substitute) from each country, appointed by the member organisations of the same country. The Advisory Board meets twice a year to discuss current priorities and give suggestions to the WAVE team and Board. The WAVE Spring Advisory Board meeting was held in Vienna, Austria, from 15-17 May 2023. 40 WAVE members comprising of both EU as well as non-EU countries and representing a total of 32 countries participated in the meeting. Topics included discussions on internal procedures at WAVE, regional meetings, advocacy & strategic issues, updates on the WAVE Thematic Working Groups, the preparation for the WAVE Country Report 2023, and an overview of current WAVE projects, among other.

The WAVE General Assembly

was held online on 3 October 2023. It provides an essential platform for all WAVE members to engage in important decision-making and monitoring activities including annual activities, financial budget, and the biannual election of the new WAVE Board. During this year's General Assembly, the WAVE Board Elections took place, warmly welcoming newly elected members Tatevik Aghabekyan (Armenia), Gorica Ivić (Bosnia and Herzegovina) and Sara Kirkpatrick (Wales) to the WAVE Board and gratefully discharging outgoing Board members Dušana Karlovská (Slovakia), Branislava Marvánová Vargová (Czech Republic) and Baljit Banga (UK) after years of dedication. The General Assembly welcomed 41 participants from 26 countries in total.

The Fall Advisory Board meet-

ing was organised in Madrid, Spain, on 18 October 2023, and was held in-person. Discussion topics were dedicated to internal processes, intersectional approaches within WAVE, WAVE's strategic plan and priority topics. In total, 37 WAVE members participated in this meeting representing 23 countries.

Discussion FORUM

The WAVE Discussion Forum aims to fortify efforts to facilitate exchange between members and to encourage open and informal discussions on country developments and burning issues. This year's Discussion Forum took place online on 23 March 2023 and enabled dialogue on building alliance and solidarity amongst women's organisations, addressing the implementation of international legislation such as the Istanbul Convention, and tackling high-priority topics such as child custody proceedings in the context of violence against women, among other. In total, 20 WAVE members participated representing 13 countries.

REGIONAL MEETINGS

In 2023, WAVE began organising regional meetings with members with the aim of enabling us to hear from members directly and connect those members who are in the same region and may be facing similar political and other issues to strengthen WAVE's regional cooperation and consolidate advocacy efforts. Based on discussions during the Spring Advisory Board meeting 2023, the following regional division was defined:

- North Europe encompassing 18 members in 8 countries;
- 2. East-Central Europe encompassing 21 members in 7 countries;
- South-East Europe encompassing 34 members in 9 countries;
- West-Central Europe encompassing 46 members in 9 countries;
- 5. South Europe encompassing 33 members in 8 countries; and
- 6. Eurasia encompassing 22 members in 5 countries.

The first online pilot meeting for South Europe took place on 26 April 2023. Starting in 2024, we will plan two in-person regional meetings per year over a period of three years, so that all six regions within WAVE will have a chance to take part in an in-person meeting.

STRATEGIC PLANNING

Throughout the year, **11 Board meetings** took place, two of which were in person; one in Vienna, Austria, and one in Madrid, Spain. During these meetings the eight Board members are joined by the Executive Director and Operations Coordinator. They discuss key strategic issues, guide network activities and work on the priorities of the current and upcoming year. This year's strategic planning sessions were particularly to the planning of the newly established regional meetings and the WAVE Conference in Madrid as well as the overall restructuring of procedures within the WAVE Network.

WORKING GROUPS

The WAVE team coordinates two Thematic Working Group, consisting of team members and around ten professionals from WAVE member organisations and operating since 2022. The working groups meet regularly online to discuss recent developments, create synergies and develop tools for mutual exchange of knowledge.

The WAVE Thematic Working

Group on primary prevention focuses on the importance and need for primary prevention work and how it can complement and inform the work of women's specialist services in combatting violence against women and girls. It is dedicated to identifying obstacles and existing solutions and tools to advocate

effectively for primary prevention across Europe. The working group also explores existing efforts regarding primary prevention within the WAVE member organisations to exchange promising practices. In 2023, the working group developed a publication on primary prevention which was made available to all WAVE members, on the members-only section of the WAVE website.

The WAVE Thematic Working Group on supporting migrant

and refugee women aims to share promising practices on how women's specialist services can effectively support migrant and refugee women. We also aim to outline the needs of our members regarding service provision to migrant and refugee women and identify areas for improvement to ensure intersectional approaches and inclusivity. Additionally, our focus extends to contributing insights that can inform advocacy and lobbying for migrant and refugee women at both national and European levels, addressing their unique needs for support.

SOLIDARITY MEETINGS

The WAVE office is committed to supporting WAVE members who are experiencing conflict and crisis or emergency situations (i.e., earthquakes, floods, epidemics, and unprecedented political unrest), to enable them to continue their invaluable work. Therefore, we have extended the solidarity meetings, which started as a response to the war in Ukraine, to all members navigating humanitarian, political, social, economic, and environmental challenges obstructing their efforts in preventing and addressing violence against women and girls. The WAVE Solidarity Meetings were held in February, May, and September 2023, and welcomed members from Ukraine, Armenia, and other countries directly or indirectly impacted by crises.

WAVE advances data collection, research, and knowledge on violence against women and girls. This includes the publication of resources like the biennial Country Report, toolkits, handbooks, and training manuals, as well as the dissemination of our outputs on the digital sphere. Our communication efforts are directed towards raising awareness about the prevalence of violence against women and girls, emphasising the experiences and initiatives of WAVE members, women's specialist services and feminist civil society organisations throughout Europe. The objective is to provide information on political, advocacy, and policy-related developments, and civil society-based progress in the field of women's rights, particularly in regard to violence prevention and protection at national and European level. Our communication channels, including various social media accounts, are strategically designed to reach diverse target groups, highlighting the pivotal role of women's specialist services in

addressing violence against women and empowering survivors across different demographics.

For instance, our <u>newsletter</u>, which as of 2023 is disseminated monthly, was sent to around 1,300 subscribers on the mailing list (made up of both WAVE members and interested individuals outside of WAVE), providing information on upcoming WAVE events, news from our network, and international news, such as political developments and updates from our members.

Within our <u>online magazine</u>, we feature impactful content encompassing engaging articles, inspirational interviews, and insightful commentary. These contributions spotlight the endeavors and accomplishments of women's specialist services, feminist women's human rights defenders, and youth activists throughout Europe. The focus is on addressing and preventing violence against women in its various forms and dimensions.




The WAVE podcast "No More Violence Against Women" is dedicated to amplifying WAVE voices and to give insight on topics pertaining to violence against women including violence prevention and protection, different forms of feminist activism, youth engagement, advocacy and campaigning, and important legislation and policies. In 2023, WAVE published four podcast episodes, tackling cyberviolence, perspectives from women's human rights defenders outside of Europe, inclusive feminist activism and art used as a tool against violence









against women. For the third year, we collaborate with Radio Orange 94.0, the largest community radio in the German-speaking region with broadcasts in 25 different languages, during the year, particularly in the frame of the **16 Days of Activism Against Gender-Based Violence** campaign to effectively promote the podcast and increase its visibility. All podcast episodes can be listened to on the <u>Cultural</u> <u>Broadcasting</u> Archive and <u>Spotify</u>.

KEY PUBLICATIONS

Several key publications were delivered in 2023. In November, the WAVE Fempower magazine was published, focusing on the impact of institutional violence on women and girls as a follow-up to the topic of the 25th WAVE Conference. A total of nine articles were submitted, each of these shedding light from different angles on this form of oppression and abuse of power that limit women & girls' access to rights while at the same time highlighting the experiences, efforts, and engagement of women's specialist services to protect and support survivors affected by institutional violence.

Furthermore, we published three translations (Croatian, German and Hungarian) of the Guidelines for safeguarding and empowering children within women's specialist services, and developed the **WAVE toolkit** for victim-friendly judicial practice in child custody, contact and visitation matters entitled <u>"Safety as the best interest of the child"</u> on women's and children's rights in custody proceedings. The findings of the toolkit were presented to WAVE members in the workshop "Tackling institutional violence performed by the justice system inchild custody proceedings" during the WAVE Conference 2023.

In the scope of the WAVE Thematic Working Group on primary prevention, the working group developed an internal publication entitled "A life free from violence – Primary prevention as the key to eliminating violence against women and girls" highlighting the importance of primary prevention in the context of violence against women and girls and showcasing the work that is already being done around this topic in the network. The goal of this publication is to shed light on how the network can advocate for primary prevention while continuing to support survivors who have experienced violence, and to pave the way to strengthening our work on prevention in general and on primary prevention in particular.

The year concluded with the publication of the WAVE Country Report 2023, which aims to depict the situation of women's specialist services in Europe from a feminist civil society perspective and as a reminder of why women's specialist services are best placed to provide support for women, their children and girls who are experiencing gender-based violence. The WAVE Country Report is a unique tool and the only report of this kind available in Europe. This year's report highlights the status and value of women's specialist services in not only tackling gender-based violence against women, but for the first time also in preventing gender-based violence against women.






ONLINE TOOLS

The **Members Only section** serves as a space only accessible to WAVE members where internal documents, trainings, webinars, and materials are shared. Furthermore, it is meant to foster and facilitate exchange and dialogue within the membership, and improve communication and information sharing. The Members Only section is an integrated part of the WAVE website and was continuously updated throughout the year.

Another important feature on the website is the <u>"Find Help" Database</u>.

This is the only European database containing around 1,440 entries of women's specialist services that is publicly available 24/7. The database encompasses information collected by us through our member organisations. The database is a useful resource for anyone affected by violence, women's organisations, and practitioners working in the field to find help near-by. In 2023, this important resource was accessed 1,932 times.

In the scope of the **"Information Centre"**, we are available during workdays for consultations on international questions related to violence against women. Requests typically include interviews/statements on current developments, invitations to speaking events, project partnership requests or other specific expert knowledge, such as the legislation in a specific country or where to find information on promising practices. In these cases, we answer these questions with our combined expertise in the sector or facilitate the communication with our members who are experts or with other institutions. As violence does not stop at borders, we also respond to cross-border support requests from survivors, counsellors of women's specialist services or other individuals involved, such as friends and family. In these cases, survivors often need to flee from one country to another or face other challenges related to different legal or migration status. We refer them to appropriate services in the relevant countries and provide support whenever possible. In 2023, the WAVE team processed 149 information requests, out of which 34 were cross-border requests.





WAVE COUNTRY REPORT 2023

The status and value of women's specialist services in preventing and tackling genderbased violence against women

The WAVE Country Report 2023 provides an overview of statistics related to women's specialist services in 46 European countries, namely national women's helplines, women's shelters, women's centres, specialist services for survivors of sexualised violence, and primary prevention services. The report seeks to highlight which European countries, within and outside the EU, meet the minimum standards of the Istanbul Convention in terms of service provision. It also includes a section on femicide. Moreover, the report provides individual country profiles for the 46 countries included in the research.


Women's helplines

Percentage of countries with at least one national women's helpline; EU and non-EU




Women's shelters

4. Project work

Besides our ongoing core work, we also partner in projects on international and European level.

PREVENTING AND RESPONDING TO GENDER-BASED VIOLENCE DURING THE WAR AND IN POST-WAR SETTINGS

In 2022, WAVE in partnership with the OSCE Gender Issues Programme/WIN Project started a new project to address capacity building and exchange of promising practices between women's specialist services on how to meaningfully support survivors of violence and civil society organisations in conflict and post-conflict areas. The WAVE members involved in the project are the Sexual Assault Crisis Center (Yerevan, Armenia), Women Fund Sukhumi (Kutaisi, Georgia), Foundation United Women Banja Luka (Banja Luka, Bosnia & Herzegovina), and Centre "Women's Perspectives" (Lviv, Ukraine).

In 2022, a toolkit was developed not only to present the harm and challenges posed by conflicts but also to document promising first-hand practices with concrete examples from the four WAVE members including their initiatives and recommendations as women's organisations who experience and have experienced war. The toolkit was launched in November 2022 in Tbilisi, Georgia, during a conference addressing civil society activists, representatives of governments, and international organisations from the South Caucasus, South-Eastern and Eastern Europe.

The Toolkit "Preventing and responding to gender-based violence during the war and in post-war settings – Experiences and recommendations of women's NGOs" is available in five languages: English, Bosnian, Georgian, Armenian and Ukrainian.

Following the toolkit and the great interest received from national and international stakeholders, in 2023, the project partners developed a training manual to reach more women's organisations and other actors involved in supporting survivors of gender-based violence. Through this training programme, the participants can learn about new strategies, share their experiences, and improve collaboration with other stakeholders, for instance through advocacy activities. This training manual addresses facilitators who intend to deliver interactive training on conflict-related gender-based violence and the existing best practices/strategies employed by women's organisations. It consists of two parts: the first part contains guidance on how to successfully facilitate the training, e.g., through feminist pedagogy principles and trauma-informed training delivery. The core part contains four training modules and related instructions for facilitators. Each module includes learning objectives, facilitator notes, module overview, and a detailed plan for the training session.

The training manual is available in five languages: English, Bosnian, Georgian, Armenian and Ukrainian.

SAFEGUARDING AND EMPOWER-ING CHILDREN


The project <u>"Safequarding and</u> <u>Empowering Children"</u> was launched in 2022, as a response to the need to tackle the institutional capacity of different actors regarding child safeguarding policies.

WAVE members involved in the project are Autonomous Women's House Zagreb (Croatia), NANE Women's Rights Association (Hungary), ZIF – Central Information Office of Autonomous Women's Shelters (Germany), and the Women's Rights Foundation (Malta).


Within the project, a comprehensive child safeguarding framework for women's specialist services, the <u>Guidelines for safeguarding and</u> <u>empowering children</u>, which can be adapted to different national contexts, was developed in 2022. The guidelines delve into the legislative context by addressing key international norms for the rights, protection and safeguarding of children, explain the foundations and purpose of the child safeguarding guidelines, and highlight safeguarding areas, factors and procedures for protection. The comprehensive child safeguarding framework is available in four languages: English, Croatian, German and Hungarian.

In 2023, the project aimed to strengthen international movement-building for more child-friendly custody proceedings in courts, by developing a toolkit with the focus on safety as the best interest of the child in custody proceedings. The Toolkit for victim-friendly judicial practice in child custody, contact and visitation matters provides insights on promising practice/recommendations for more child-friendly custody proceedings across Europe. This document can be used interdisciplinarily and serves to help to improve the institutional/judicial practice taking place before courts, administrative authorities, and all other bodies that have responsibility in custody and visitation procedures. The aim is to address the linkage between protection against domestic violence and decisions on custody and visitation rights. Therefore, with this toolkit, the protection and best interests of children are brought into focus.

TAVAM – TOGETHER AGAINST VIOLENCE IN AUSTRIA AND MOLDOVA

At the end of 2022, WAVE launched a new project in cooperation with the Moldovan umbrella organisation for violence protection "National Coalition Life Without Violence" titled TAVAM (Together Against Violence in Austria and Moldova). This project aims to strengthen the capacity of Moldovan women's specialist services and to advance the transfer of knowledge between Austrian and Moldovan organisations. For this purpose, four trainings were organised from March-December 2023 involving experts in the field of violence against women from Austria as well as Bosnia and Herzegovina and Moldova, and were attended by women's specialist services from the National Coalition, followed by a conference in Chisinau, where the importance of multiagency collaboration for feminist networks were highlighted.

The project has been extended to June 2024 and is funded by the Austrian Ministry for Social Affairs, Health, Care and Consumer Protection.

Women's specialist services support survivors by facilitating informed choices and ensuring the highest quality of support tailored to their particular context and needs, placing the women and their active consent and participation at the centre of every intervention.

1. Our members

The WAVE Network is comprised of 174 Members, located throughout 46 European countries. Our members are women's rights feminist activists who work towards preventing and tackling violence against women and their children. These include women's organisations, networks, and women's specialist services such as women's shelters, women's centres, helplines, rape crisis centres, and policy and advocacy organisations. Additionally, individual WAVE members are key experts in the field of VAW with close relationships with other members in their country and provide research and other related support to the network.

The WAVE office serves as a linchpin for the whole WAVE Network by providing capacity-building trainings; supporting women's specialist services in their advocacy and campaigning efforts; conducting research on the implementation of international and European legal standards such as the Istanbul Convention; and encouraging collaboration and partnerships between WAVE Members within and across countries.

Research in several European Countries has demonstrated that for every €1 invested in women's specialist services, they return on average 6–9 times this cost in social value to society, as their holistic service provision means that there is less need for repeated police and social services interventions, fewer hospital visits, less emergency housing costs, less lost working hours because of injury, and most importantly significantly fewer human costs of ongoing suffering and trauma.²

In the WAVE Network, there are 33 national networks, 128 individual organisations, and 13 individual members. Of these, 91 are located within the EU and 83 operate in a European country outside the EU. Taking into account the organisations in the networks that are part of WAVE, it is estimated that over 1600 women's organisations make up the WAVE Network.

MAIN SERVICES OF WAVE MEMBERS




Our members provide a number of essential services to survivors of violence against women. The most common services are counselling and therapy, advocacy & lobbying, as well as public awareness raising. Other services include shelter accommodation, helpline support, legal advice, training for professionals, and prevention work. In terms of forms of violence addressed, the majority of our members work on domestic violence, followed by sexualised violence and child abuse. Other forms of violence include trafficking in women, honour-based violence, violence in conflict situations, forced marriage, cyberviolence, and female genital mutilation (FGM).



2. Our team and network structure

The WAVE team consists of 12 employees responsible for the implementation of all the operational work. The WAVE Advisory Board supports the WAVE Board in the development, implementation and evaluation of policies and activities, in order to intensify the coordination and planning for the WAVE Network, and to ensure representation from all regions. It consists of one Delegate and one Co-delegate (substitute) from each country. The WAVE Board is comprised of eight members from different countries and oversees the strategic development of the network. It is elected by the General Assembly that is comprised of all members. WAVE BOARD

Marcella Pirrone (President) is a feminist lawyer with over thirty years of experience of promoting and advocating for the rights of women in Italy and at international level. She is also the co-founder and President of a women's shelter, co-founder and Board member of the Italian umbrella organisation D.i.Re and university law professor.

Susana Pavlou (Vice-President) is the Director of the Mediterranean Institute of Gender Studies. She has served as an expert on violence against women for European networks and organisations including EIGE, and the Council of Europe. In Cyprus, she is currently also President of the Advisory Committee for the Prevention and Combating of Violence in the Family.

Tatevik Aghabekyan is the President of the Sexual Assault Crisis Center in Armenia, and a staunch advocate for women's rights and gender equality. She was involved in establishing the Coalition to Stop Violence Against Women in 2010, and pioneered educational initiatives fostering crucial conversations on sexualised violence and the need for sex education in Armenia.

Selime Büyükgöze is a volunteer at Mor Çatı Women's Shelter Foundation, a feminist organisation working in the field of violence against women. She is mostly involved in communication activities, advocacy and monitoring activities on violence against women in Türkiye. She holds a PhD in communications and works as a university lecturer.

Gorica lvić is the Executive Director of the United Women's Foundation from Banja Luka. She is a social worker by profession, previously engaged in health institutions and the Commune for women with substance abuse issues. She is also an author, co-author, and editor of different research and manuals in the area of gender-based violence.

Sara Kirkpatrick is the CEO of Welsh Women's Aid, supporting specialist services all across Wales. She is an Intimate Partner Violence (IPV) specialist having worked in criminal justice and community settings for over 30 years. She is also a Trustee with Youth Realities, and a visiting Lecturer at Winchester University in the social work department.

Veronica Teleuca is the coordinator of the National Coalition "Life without Violence", comprising 22 civil society and service provider organisations. She holds a Masters degree in clinic psychology and is also a lawyer, women's human rights defender and justice sector expert, with relevant experience and understanding of working with women's organisations.

Irene Zeilinger is a sociologist and the founder, former executive director and current international affairs officer at Garance. She holds over 25 years of experience in feminist self-defence and prevention and has participated in the writing of the shadow report on Belgium's implementation of the Istanbul Convention and sits on the advisory board of the Belgian francophone action plan to combat violence against women.
