



THE WAVE NETWORK

The WAVE Network was established in 1994 as a network of women's NGOs and women's specialist services (women's shelters, women's centres, intervention centres, helplines and other services). The main objective of WAVE is to work towards the elimination of all forms of discrimination and violence against women and their children, to promote the rights of women and girls to live free from violence in both the public and the private sphere, and to promote the human rights of women and girls.

The WAVE office serves as a linchpin for the whole network of WAVE.

The WAVE Network is comprised of **179 Members** (Aug. 2024), located throughout **46 European countries**.

- 14 individual members

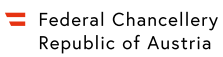

Additionally, we answer requests from governments, academics, the media and from the general public.
